**Level II Standard Course Information**

**Course Description**

This is a lecture and practicum course designed to give experienced educational therapists continued training in accordance with the NILD intervention model. Five broad topics are addressed in the Level II course: questioning and thinking skills; technique instruction and refinement; program development; assessment; and student evaluation.

**Course Prerequisites:**

- Successful completion of Level I training
- Participation in required NILD regional conference sessions OR notes from DVD required sessions
- Minimum educational therapy student contact of 1 years/100 hours

**Course Objectives:** Successful completion of this course should equip the educational therapist to more effectively implement NILD techniques and to have a wider vision for the overall program at his/her school or private practice.

**Credit:** Four semester hours of optional graduate credit is offered at all locations. Upon successful completion of the course a certificate awarding six CEUs will be given to all participants.

**Class size:** Maximum 22. Registration closes – without exception – three weeks prior to the start date or when fully enrolled, whichever occurs first.
